AUDITOR'S OPINION

We have examined the Statements of Federal Land Payments of the State of California (the Statements) covering the periods October 1, 1977 through September 30, 1978 and October 1, 1978 through September 30, 1979. Our examination was made in accordance with (1) the standards for audit of governmental organizations, programs, activities, and functions issued by the Comptroller General of the United States, as they apply to financial and compliance examinations, and (2) the Audit Guide for Bureau of Land Management Payments in Lieu of Taxes Program prepared by the Office of the Inspector General, U. S. Department of the Interior, and accordingly, included such tests of the accounting records and other data, and such other auditing procedures as we considered necessary in the circumstances.

The Statements were prepared on the basis of cash disbursements made by the State of California and received by qualified local governmental subdivisions thereof during the periods mentioned in the preceding paragraph under 31 U.S.C. 1601 et seq. This basis of reporting Federal land payments is prescribed by U. S. Department of the Interior Rules and Regulations (42 FR 1881.0-5), and is in accordance with the provisions of the October 16, 1978 Comptroller General of the United States Decision (B-167553), and as such the Statements are not intended to be presented in conformity with generally accepted accounting principles. This report is intended solely for filing with governmental agencies and is not intended for any other purpose.

In our opinion, the Statements present fairly the payments made by the State of California and received by qualified local governmental subdivisions thereof under 31 U.S.C. 1601 et seq., in accordance with the regulatory requirements on the basis of accounting described in the preceding paragraph, which basis has been applied in a manner consistent with that of the preceding year.
